## 1. NAME OF THE TRUST :-

#### 2. OFFICE :-

# 3. AIMS AND OBJECTS :-

The aims and objects for which the Trust is established are as under :-




- h) To set-up establish and maintain libraries reading rooms, and institutions for study and research.
- i) To award prizes, stipends, scholarships, fellowships and other forms of assistance and to open the branches and affiliate institutions or bodies having similar objectives.
- j) To carry on relief work among the people who are in distress to work for upliftment of women in general girl and windows, orphans, illitereate, old-aged handicapped and mentally retarted persons or persons.
- k) To arrange for Eye Camps and Blood donations camp and to help and assist and Government Authorities and/or suffering humanities, during flood, fire, famine, cyclone, earth-quake, epidemic, storms, accident etc.
- To arrange and organies social, cultural and educational programmes and functions from time to time including get together picnic celebrations of festiveals indepnedene day and other national days and occasions.
- m) To orgnise a caprup to give education of Budha Municipls/Buddhim.

To do all other acts, deeds and things even which have not been specified above under the aims and objects, but which may become necessary to be performed at any stage in case the charitable purpose in not forfeited.

All the income, earning, moveable and immoveable properties of all trust shall be solely and applied thereof shall not be paid or transferred directly or indirectly by way of dividends bonus, profit or in any manner whatsoever to the present or bonus, profit or in any manner whatsoever to the present or part TRUSTEE(S) of the Trust or to any persons (s) claiming part TRUSTEE(S) or more of the Trust or to any person(s) through any one or more of the present or the part claiming through any one or more of the present or the part Trustees, No Trustees of the Trust shall have any personal in any profit whatsoever by virtue of his trusteeship.

Provided always and it is hereby specificially declared that if anyone or more of the objects specified above are held not to be the objects of charitable nature, the Trustees shall not carry out such objects as if the same are not incorporated in these presents but the validity of the trust careated by these presents as a trust for charitable purposes shall not be affected in any manner.

#### ADMINSTRATION :-

That after the death of the SETTLER the vacancies in the Trust shall be filled bythe continuing Trustees.

That any person(s) can be appointed as Trustee by the Governing Body who believes in the aims and objects and Rules and Regulations of the Trust.

That the New Trustee of the Turst who will be appointed by the existing Governing Body shall pay the membership fee/subscription as decided by the Governing Body from time to

That the TRUSTEE(S) shall case to be TRUSTEE(S) of the Trust in case :-

- 1) The Trustee(s) dies.
- The Trustee(s) resigns. 2.
- The Trustee(s) become insolvent.
- The Trustee(s) declared to be of unsound mind.
- The Trustee(s) act contrary to aims and objects of the Trust and is removed by the President.
- The Trustee(s) convicted by the Court of Law on the offencses involving moral turipitude.

# 7. ELECTION :-

That the Trustees of the Trust shall elect the Executive member/office Bearers of the Governing Body casting vote through a ballot paper or by showing hands after every three years.

That the seven executive members of the Governing Body shall be elected by the Founder Trustee among thereselves and remaing will be elected from all trustees.

#### 13. FUNDS OF THE TRUST :-

All recepts, funds, donations, gfts, membership/trusteeship fees, etc. etc. shall be deposited into the natiolnalised/commercial Bank in the account of the trust which shall be the property/funds of the trust.

#### 14. OPERATION OF BANK ACCOUNT :-

The Bank accounts of the Turst may be operated by the Treasurer the President. In case it is not feasible to operate the Bank account by any of the above office bearers of the trust, this can be assigned to any other trustee/employees of the trust through a Resolution passed by the Governing Body.

#### 15. MANAGEMENT :-

- a) The trust shall be managed by the governing body. The meeting of the Governing Body shall be chaired by the President and in his absence/non availability by the Gen. Secretary.
- b) The decision by the Governing bodyshall be decided by a majority of votes of the Trustees present in cased of tie-up the president shall exercise casting vote.

# 16. FUNCTION AND POWER OF THE GOVERNING BODY :-

The Governing Body shall perform the following function :-

- 1) The Governing body shall br responsible for execution and implemention of the objects and authorised policies of the trust.
- 2) It shall authorise all expenditure to achive the objects the trust.
- ご) It shall cause the books of accounts to be mainted regularly with all essential supporting documents and evidences.
  - 4) It shall be authorised to appoint the auditors of the trust and to get the account of the trust audited on regular basis and be responsible to reply all audit queries.
  - 5) It shall hold a meeting afterevery half year and additionally it shall hold a meeting when specially called for by the president or on receipt of written request of at least three trustees of the trust within a period of one week from the date of receipt of such request addressed to the president/Gen. Secretary.

- The trustees will attend the meeting called from time to time present their views in a constructive menner and will time their fulltest co-operation in the execution of the programme and function of the trust.
- 8). The Governing body shall cause minutes book to be kept of the proceedings which shall be read out and signed by the president/chair person of the ensuing meeting for the pruposes of records and references.
- 9) The Governing body may enter into arranagements with Govt. local authorities other quasi Govt. bodies in order to acquires land properties and other assets to promote and achieve the objects of the trust.
- 10). The governing body shall have the entire control and management of business and affairs of the trust and shall have all such powers enabling them generally to carry out the eobjects of the trust as are required bythe trust under the various laws prevailing in the country without prejdices to the generally of the for going powers of the object and purposes of the trust have the following powers namely:
- a) To acuire immoveable and moveable properties accourding to the needs of the trust with the without building and structure thereon by the way of purchase absolutely or by way of lease, thereon, gifts or in any other rform of acquisiting at such exchagne, gifts or in any other rform of body may agree to.
- b) To construct such building(s) and structure(s) and may be necessary from time to time, improve, alter or extend the same or any part thereof and to equip the same with all such amenties and facilities as the governing body may deem fit and proper.
- c) To employ staff on remuneration or gratuitously on such terms as the governing body may deem fit and proper and to suspend, discharge or dismise them.
- d) To apply for receive and utilise any Govt. Municipal, or other grants or allowances to achive the aims and objects of the trust or otherwise and to deal with the same accordingly to the
- e) To acceipt voluntary donation either in cash or in any kind and/or under any arranagement and to raise meoney otherwise for the purpose of carrying out object and activities of the trust and to accept subjscriptions gift and endowments of moveable or immoveable properties for the same purpose.

- To solicit, receive adminster and use any gift, voluntary, constribution, donation of any kind of money or any property whether susbject to any trust or not for any objects of the trust and to undertake and carry out office duties and functions of trustees, managers and administratorsk, either solely or jointly with another or other for or in repsect of any gifts, donations, trusts, fundations or property whether vested in the trust or otherwise not with standing that the carrying out of any specifically mentioned therein.
- To negotiate and to enter into any arranagement with any Govt. University, Municipality or any other public or Pvt. Aauthority body or association with may seem beneficial or condcive to any the objects of the trust.
- h) To borrow or receive money on deposit upon such terms and with or without security on all or any of the prorperties and assets of the trust present or future, as the Governing body shall deeem necessary or expendient.
- To deposit money in any bank or banks either in saving or current accounts, fixed deposit or accounts of any other decription and to withdraw such moneys from time to time, and also to deposit money in Govt. Post Ofices or in co-operative socieities and to withdraw such money from time to time or at any time on such manner as the governing body may deem fit and proper.
- j) To maintain a building fund to meet the expneses of capital nature and to pay into such fund moneys at such time and in such amounts as the governing body may, from time to time decide.
- k) To establish and maintain a reserve fund of such amount as to governing body as may thing fit for the promotion of the activities of the trust.
- 1) To appoint any person or persons as the governing body may deem fit and proper for the purpose of representing the trust in any legal aor other proceedings to be instituted by the against the trust and/or governing body.
- To invest and deal with the fund of the trust not immediately required to be used for the activities of the trust.
- To framerules for the day to day aconduct of its business.
- The Governing body is impower to nominate chairman, manager enclouding other member on the managing committee  $\alpha$ constituted to sum the school etc.
- To constitute medical, legal and/or judical or anyother committees/sub-committees for cuarrying out the activities of the trust amongst specific class of persons and name then as respective wings of the trust, define their constitution appoint their office bearers and other committee members and duration and maintain their accounts separately for their entrance fee, subjectiption, volutary, contribution/donations, expenses etc. under the secretary/trasurer of the trust.

### 17. POWER AND DUTY OF THE BEARERS

#### 1. PRESIDENT :-

He will be the head of the trust and preside over the meeting of the general body. He will have the right of casting of the vote in case while.

# 2. GENERAL SECRETARY :-

- a) To sign on behalf of the trust conduct its correspondence and to record the proceeding/meeting.
- b) To summon and attend the meeting of the General Body.
- c) To call ordinary general meeting if desired on written requested of 2/3rd members.

#### 3. TREASURER :-

The treasurer shall receive all receipts and deposit the same in the bank and he will keep with him Rs.10,000/- and the balance amount deposite bank and all payments shall be made against pass voucher and will keep and proper account of all receipts and expenditures and will submit the account to the general secretary as and when demanded by the general secretary duly audited by the auditor appointed by the governing body.

# 18. PROPERTIES AND FUNDS OF THE TRUST :-

All the properties either moveable or immoveable belonging to the trust shall be sold transferred, gifted to any persons with the 3/4th majority of the governing body.

# 19. FINANCIAL YEAR :-

That the financial year of the trust shall commence on Ist day of april and end on 31st day of March every year.

# ZØ. AUDIT OF ACCOUNT :-

The accounts of the trust shall be auditied by acqualfied auditor or afirm of auditors who shall be chartered accountant within the meaning of the chartered accountant act 1949 and who shall be appointed by the governing body.

- 21. The Governing Body or any trusteee thereof shall not be held personally responsible for any thing dies in good faith in the performance on his or her/his duties in accordance with the constitution of the trust.
- 22. A notice may be served upon any trustee either personally or by sending it by registered post addressed to such trusteee at his registered address for service. In case of the meeting of Governing Body or the extraordinary or emergency metting a notice of seven days shall be sufficient.
